Administrative Offense Citations

In accordance with City Code §200.03 the following City Administration has the authority to issue Administrative Fines:

Police Department Fire Chief City Administrator Public Works Director

Implementation of Administrative Fines

Administrative Offenses Defined:

An Administrative offense is a violation of a provision of the City Code or state Law and is subject to the administrative penalties set forth in the schedule of offenses and penalties referred to in Sec. 200.09, entitled “Offenses and Penalties”. An administrative offense is not a crime.

Purpose:

Administrative Offense procedures established pursuant to Section 200.01 are intended to provide the public and the City of Blackduck with an informal, cost effective and expeditious alternative to traditional criminal charges for violations of certain City Code provisions. The procedures are intended to be voluntary on the part of those who have been charged with Administrative Offenses. At any time prior to the payment of the Administrative penalty as is provided for thereafter, the individual may withdraw from participation in the procedures, in which event the City may bring criminal charges in accordance with the law. Likewise, the City of Blackduck in its discretion may choose not to initiate an administrative offense and may bring criminal charges for the first instance. In the event a party participates in the Administrative Offense procedures, but does not pay the monetary penalty which may be imposed, the City of Blackduck will seek to collect the costs of the Administrative Offense procedures as part of a subsequent criminal sentence, in the event the party is charged and is adjudicated guilty of the criminal violation.

Payment:

In accordance with Section 200.04 of the City Code, payment is due within fifteen (15) days of the issuance of the notice, pay the amount set forth on the schedule of penalties for the violation or you may request a hearing in writing. The penalty may be paid in person or by mailing it to the:

Hearing:

Any person contesting an Administrative Offense pursuant to Section 200.05 may, within seven (7) days of the time of issuance of the notice, request a hearing by a hearing officer who shall forthwith conduct an informal hearing to determine if a violation has occurred.

Failure to Pay:

In accordance with Section 200.07 of the City Code, in the event a party charged with an Administrative Offense fails to pay the penalty, a misdemeanor or petty misdemeanor charge may be brought against the alleged violator in accordance the applicable statutes. If the penalty is paid or if an individual is found not to have committed the Administrative Offense by the Hearing Officer, no such charge may be brought by the City of Blackduck for the same violation.
